Sied sgwter

Beth yw sied sgwter?

Yn ddiweddar mae Cartrefi Cymunedol Gwynedd (CCG) wedi buddsoddi mewn nifer o siediau sgwteri ar draws Gwynedd er mwyn cadw a gwefru sgwteri symudedd tenantiaid yn ddiogel. Mae'r siediau sgwteri wedi eu dylunio yn arbennig i gadw sgwteri symudedd yn ddiogel.

Mae yna sawl sied sgwteri ar draws Gwynedd ac mae CCG gweithio yn proactif gyda tenantiaid er mwyn cael mwy o siediau lle bo'n bosib.

Pwy all wneud cais am sied sgwter?

Rhaid i berson gwrdd â'r criteria canlynol cyn cael eu hystyried am sied sgwter:

- Bod yn denant i Cartrefi Cymunedol Gwynedd sy'n byw mewn safle tai gwarchod neu fflatiau cyffredinol (sy'n rhannu ardaloedd cyffredin a chynteddau)
- Tenant gyda sgwter symudedd Dosbarth 2 neu 3 (gweler Taflen Ffeithiau Sgwter Symudedd)
- Dim lle addas arall i gadw a gwefru'r sgwter symudedd

Os nad ydych yn siŵr eich bod yn cwrdd â'r criteria, cysylltwch gyda CCG ar 0300 123 8084 am sgwrs pellach.

Sut i wneud cais am sied sgwter?

Os oes gennych sgwter symudedd neu eich bod yn meddwl prynu neu logi sgwter symudedd ond heb le diogel i'w gadw a'i wefru, yna gallwch wneud cais am sied sgwter. Am gopi o'r ffurflen gais, cysylltwch gyda CCG ar 0300 123 8084.

Unwaith y byddwn wedi derbyn eich ffurflen gais bydd eich cais yn cael ei asesu a bydd CCG yn cysylltu gyda chi wedyn gyda'r penderfyniad.

Ni allaf weld bod yna siediau sgwteri ar fy safle, allai wneud cais beth bynnag?

Gallwch, er nad oes yna siediau sgwteri ar eich safle ar hyn o bryd gallwch barhau i gwblhau ffurflen gais a bydd CCG yn asesu eich anghenion a'r sefyllfa. Bydd bob cais yn cael ei asesu yn unigol drwy'r panel addasiadau a byddwch yn cael gwybod am eu penderfyniad.

Beth arall heblaw am sgwter symudedd y gallaf gadw yn y sied sgwter?

DIM BYD. Mae yna bolisi llym yn CCG na allwch storio dim byd ond y sgwter symudedd yn y sied sgwter. Os na fyddwch yn cadw at y gytundeb gall hyn olygu colli y sied sgwter.

Mae gan CCG yr hawl i wneud archwiliad di-rybudd ar y sied sgwter ar unrhyw adeg i archwilio ei gynnwys a'i gyflwr.

Oes rhaid i mi dalu am sied sgwter?

- Fel rhan o'r gytundeb, bydd CCG yn codi tâl personol blynyddol o £52 am ddefnyddio'r sied ac am wefru'r sgwter symudedd
- Fel rhan o'r gytundeb byddwch yn cael gorriad am ddim i'r sied sgwter
- Bydd disgwyl i denantiaid talu am unrhyw oriadau ychwanegol, os bydd unrhyw oriadau yn malu, cael ei golli neu os oes angen newid cloeon
- Bydd tâl yn cael ei godi ar y tenant am unrhyw ddifrod i'r sied sgwter sydd ddim yn cael ei weld fel traul a gwisgo arferol

- Er mwyn ffurfioli'r gytundeb, bydd gofyn i chi arwyddo cytundeb a fydd yn amlinellu telerau ac amodau y mae'n rhaid i chi gadw atynt wrth ddefnyddio'r sied sgwter
- Os na fyddwch wedi torri unrhyw delerau'r 'gytundeb' gallwch ddefnyddio'r sied cyn hired ag sy'n bosib ac eu hangen
- Unwaith bydd eich cais wedi ei asesu a'i dderbyn bydd aelod o staff CCG yn cysylltu gyda chi i drafod telerau ac amodau'r 'gytundeb'

Scooter shed

What is a scooter shed?

Cartrefi Cymunedol Gwynedd (CCG) have recently invested in a number of scooter sheds across Gwynedd in order to safely store and charge tenant's mobility scooters. These scooter sheds are purposely designed for the safe storage of mobility scooters.

There are several existing scooter sheds across Gwynedd and CCG are proactively working with tenants to get more sheds in place where possible.

Who can apply for a scooter shed?

A person must meet the following criteria before being considered for a scooter shed:

- A Cartrefi Cymunedol Gwynedd tenant living in sheltered housing or general flats (that share communal areas and hallways)
- A tenant with a Class 2 or Class 3 mobility scooter (please refer to the Mobility Scooter Fact Sheet for more information)
- No alternative suitable area to keep and charge the mobility scooter

If you're not sure that you meet the above criteria, please contact CCG on 0300 123 8084 for a further discussion.

How do I apply for a scooter shed?

If you have a mobility scooter or are considering to purchase or lease a mobility scooter but do not have a safe area to store and charge it, then you can apply for a scooter shed. For a copy of the application form, please contact CCG on 0300 123 8084.

Once we receive your completed application form, it will be assessed and CCG will be in contact with you shortly with a decision.

I can't see any of CCG's scooter sheds on my site, can I still apply for a scooter shed?

Yes, although there might not currently be any scooter sheds on your site you can still complete an application form and CCG will assess your needs and the situation. Each case will be assessed individually via the adaptations panel and you will be informed of their decision in due course.

What else other than a mobility scooter can I keep in my scooter shed?

NOTHING. CCG have a strict policy that nothing other than a mobility scooter can be stored in the scooter shed. Failure to keep to this agreement could result in losing the scooter shed.

CCG hold the right to undertake spot checks on the scooter shed at any time to inspect its contents and condition.

Do I have to pay for the scooter shed?

- As part of the agreement, CCG will require a £52 annual personal charge for the use of the shed and for the cost of charging the mobility scooter
- As part of the agreement you will receive a key for the scooter shed free of charge
- Tenants will be expected to pay for any additional keys, if any keys are broken, lost or if a change of locks is required
- Any damage caused to the scooter shed that's not deemed to be a result of fair wear and tear could be recharged to the tenant

If CCG grant me permission to use a scooter shed, for how long can I use it?

- In order to formalise the agreement, you will be required to sign a contract which will outline terms and conditions that must be abided by whilst using the scooter shed
- If no terms within the 'contract' have been broken, you will be able to use the scooter shed for as long as is still possible and necessary
- Once your application has been assessed and deemed as accepted, a CCG member of staff will contact you to discuss the terms and conditions of the 'contract'.
